

# Minutes of the Annual General Meeting $31^{st}$ May 2016 L16 70 Franklin St Adelaide 5.30pm

### 1. Presidents Welcome

President Steve Mackie welcomed all the attendees to the 2016 PESA AGM and declared the meeting open at 5:30pm. President declared a quorum was present with 9 members physically present and acknowledged 31 proxies received. The President explained that the AGM was normally held in conjunction with the annual APPEA conference so as to allow more members to attend but under ASIC rules the AGM needed to be held within 5 months of the end of the Corporation's financial year (31st December 2015).
