

PESA DEAL DAY - 18 MAY 2026

The 2026 PESA Deal Day will bring high quality **exploration**, **appraisal and development opportunities** from Australia and beyond to the attention of the international **oil and gas industry**. This year the offerings may include the search for **hydrogen**, **helium**, **geothermal** and other energy forms in addition to exploration and development projects for **Carbon Capture and Storage**. The Deal Day is held in conjunction with the 2026 Australian Energy Producers Conference and Exhibition (formerly APPEA), thereby ensuring a wide exposure to industry leaders.

Company representatives will review the technical and commercial aspects of their opportunities via short presentations, using selected data. There will be time during the seminar to discuss additional details with interested parties in private.

Presenters will have the opportunity at no extra cost of having their project highlighted in the PESA Gazette.

Each presentation will run for 10 minutes maximum. This provides the opportunity for many and varied presentations.

IMPORTANT INFORMATION FOR PRESENTERS:

Length of talk:

Talks are limited to a very strict 10 minutes. Presenters will be given a warning at the 9 minute mark and will be expected to wrap up at 10 minutes. This allows for the maximum number of speakers possible.

PowerPoint of Presentation

All presentations must be submitted in PowerPoint format by COB **MONDAY 04 May 2026** (two weeks prior to Deal Day).

- Each presenter will be given access to a specific Dropbox folder that will only be accessible by the organisers (Wendy and Wal) and the presenter.
- o Presenters will be given Dropbox access from the date of registration.
- Presenters must ensure that files are loaded into this Dropbox folder by close of business 04 May 2026. This allows us time to upload the

presentation onto Wal's laptop, queue it, and test that it is running correctly.

- o Access to the Dropbox folder will cease on 11 May 2026.
- o If the presentation is not in the Dropbox by 11 May 2026, it will be assumed that the presenter slot is no longer required, and this will tentatively be offered to anyone on a presenters wait-list. If this is not the case and there is another reason that the presentation is not in place, please contact the organisers (Wendy or Wal) prior to 11 May 2026 to discuss next steps.
- If the presentation needs to be updated after 11 May to the Dropbox folder, it will be necessary to bring the presentation on a usb and given to Wal to update on the day of the event. There will not be the opportunity to update it into the Dropbox.
- Note: you will have to arrive by midday on the day to facilitate this.
 There will be no opportunity to test the presentation in this situation, so the risk of it running correctly sits firmly with the presenter. Please remember that there may be more than one presenter needing to update a PowerPoint on the day.

• PDF of presentation

PDF versions of each presentation will be distributed to all delegates on the completion of the Deal Day event.

- All pdf versions of presentations must be in the Dropbox by the morning of Deal Day, 18th May 2026. There is no opportunity to modify these after this date.
- o If there is no pdf version of your talk in the folder by the date of Deal Day, your talk will not be included for distribution to delegates.
